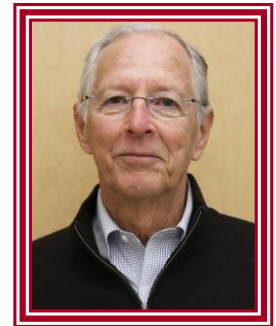

## **SAM D. STOUT**

**Department of Anthropology  
The Ohio State University**



Ever wonder how they know how they can tell when an animal roamed the earth just from studying a bone or bone fragment dug up in a farm field? How many secrets do our bones And our teeth carry and what else can scientists figure out?

Sam D. Stout received his Ph.D. in physical anthropology from Washington University in St. Louis in 1976, and is currently Professor of Anthropology in the Department of Anthropology at the Ohio State University, and Professor Emeritus of the University of Missouri Department of Anthropology.

His research interests are in skeletal biology, particularly from a microscopic (histomorphological) perspective, with an overarching interest in age-associated bone loss and its variation among populations, past and present, and forensic applications. He is a Fellow of the *American Academy of Forensic Sciences* and the *American Association for the Advancement of Science*. He is also a member of the *American Society for Bone and Mineral Research*, and *American Association of Physical Anthropologists*.

## 38<sup>th</sup> annual Columbus Kiwanis College Fair taking shape ...

The 38<sup>th</sup> Annual Columbus Kiwanis College Fair is scheduled for Monday, September 25, at the Center of Science and Industry (COSI), located at 333 West Broad Street.

Colleges and universities from more than 25 states will be sending representatives to set up information tables and to interact with area high school students. The first session will run from 9 a.m. to noon, and will accommodate those schools wishing to bring students and guidance counselors via bus. The evening session (6 p.m. to 8 p.m.) will allow parents to attend, gather information about college finances and learn more about adult education offerings of the Columbus City Schools.

## Labor Day ...

Labor Day, the first Monday in September, is a creation of the labor movement and is dedicated to the social and economic achievements of American workers.



It constitutes a yearly national tribute to the contributions workers have made to the strength, prosperity, and well-being of our country.

The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union. The Central Labor Union held its second Labor Day holiday just a year later, on September 5, 1883.

In 1884 the first Monday in September was selected as the holiday, as originally proposed, and the Central Labor Union urged similar organizations in other cities to follow the example of New York and celebrate a "workingmen's holiday" on that date. The idea spread with the growth of labor organizations, and in 1885 Labor Day was celebrated in many industrial centers of the country.

James Henderson Kyle, was one of the main sponsors of a bill to create the Labor Day holiday. He was born and raised at his family farm in Cedarville, Ohio and he is claimed by that town as being the father of Labor Day. However, Kyle was a member of the Populist Party and he served 10 years as a member of the United States Senate from South Dakota.

In recognition of this day of honor, Kiwanis Club of Columbus will not conduct its regularly scheduled Monday meeting.
