- WE DID A WEEKLY TURN IN TO PAUL BOHLMAN WITH MONEY RECEIVED THAT WEEK, A COPY OF THE RECEIPTS AND A COPY OF THE SPREAD SHEET WITH THE WEEKLY SALES HIGHLIGHTED.
- TOWARDS THE END OF THE SALE, I EMAILED EVERYONE TO REMIND THEM TO TURN THEIR MONEY IN.
