A lifelong Presbyterian, Emily grew up in Cambridge, Ohio. She graduated from Denison University with a degree in biology and physical education/athletic training. She received a Master of Science degree from Indiana University, and then served as an assistant professor/athletic trainer at Denison University for seven years before answering God's call on her life to ministry.



Emily was an active member and ordained deacon at Broad Street Presbyterian Church here in Columbus. In 2008, she graduated from Princeton Theological Seminary in New Jersey with a Master of Divinity degree. While in seminary, she served as a pastoral intern at The Brick Presbyterian Church in New York City. Emily participated in a Lilly Endowment grant for Faithful Practices for Congregational Leadership, and she received The C. Frederick and Cleta R. Mathias Memorial Award in Worship and Pastoral Ministry.

Following seminary, Emily completed a year-long hospital chaplain residency program at Riverside Methodist Hospital. In 2010, she was ordained as a Minister of Word and Sacrament in the Presbyterian Church (USA) and served First Presbyterian Church, Wooster, Ohio, as their transitional associate pastor. Returning to Columbus in 2011, Emily was called to Nationwide Children's Hospital as a chaplain in the Neonatal Intensive Care Unit. From 2012-2014, she served as the interim director of mission and young adults at Broad Street Presbyterian Church. Prior to coming to First Congregational Church, United Church of Christ, Emily served at Old Stone Presbyterian Church as their Transitional Pastor.

At First Congregational Church, Emily's role incorporates pastoral care, administration, preaching and teaching. She

## Interclub recognition program ...

Interclubbing, attending the meetings and events of other Kiwanis Clubs, is an important element of successful clubs. In addition to the expanded networking and fellowship opportunities, interclubbing allows for the exchange of ideas and seeing how other clubs approach similar challenges. This year, the Ohio District will be recognizing clubs who make a concerted effort to interclub.

- A **blue** level banner patch will be awarded to any club that interclubs with five clubs within their division and attends one division council meeting.
- A **silver** level banner patch will be awarded to those clubs that interclub with five clubs within their division, interclub for two projects or fundraisers, interclub at two division council meetings and interclub at one district event.
- A **gold** level banner patch will be awarded to any club that inter-clubs with five clubs within their division; interclub at each division council meetings during the year; interclubs at district convention AND Mid Year-Education Day; and interclubs at International convention.

Plan to attend some interclubs this year. Watch the newsletter and Activity Calendar for upcoming opportunities.

## Foundation grant cycles set ...

During this 2018-19 administrative year, Kiwanis Club of Columbus, on behalf of the Columbus Kiwanis Foundation, will place \$130,000 back into our community. Of this amount, \$80,000 will be used for scholarships, hands-on community projects coordinated by our Club committees and standing commitments, such as supporting the Summer Reading Club. The remaining \$50,000 will be made available to the community through our formal grant process.

The formal grant process requires non-profit organizations to submit their written grant applications during one of two cycles. Once received, the applications will be reviewed by our grant committee, evaluated and determined whether it will be presented to the Club Trustees for funding. This process provides a level

playing field for the non-profit organizations, in that they are <u>all</u> on the same time-line, they will <u>all</u> be evaluated using the same criteria and they will <u>all</u> be notified of their



request's status by a set date. From the Club's perspective, the process allows for a more effective evaluation process, making sure we are awarding grants for the most deserving and most impactful projects.

Here are the schedules for the two grant cycles:

## Cycle 1:

12/15/18 — Applications due 02/13/19 — Board action taken

02/16/19 - Grantees announced

#### Cycle 2:

05/11/19 – Applications due 07/10/19 – Board action taken 07/1319 – Grantees announced

These deadlines, along with the formal grant application, can be found on our Club's website. We encourage you to spread the word about our formal community grant program to <u>all</u> non-profit organizations with which you are involved.
