17th Annual Corporate Regatta

The concept is simple: Each "skipper" gets to race his/her sailboat across a pool of water using a 'Super-soaker' squirt gun as the means of propulsion. Three boats are raced in each heat, and the winner goes on to the winner's bracket. It is a double-elimination process, so all entrants are guaranteed at least two races. The winner receives a check for \$1,000, made payable to the charity of his/her choice.

When arriving at today's event, please be sure to check in at the registration table for your meal ticket and attendance credit. In addition, all yachts are automatically entered into a "best-decorated-yacht" contest, where their creativity, originality and eye-catching designs are impartially judged by a small group of "expert" design theorists. Those failing to pay their dues on time will be dropped from the roster on October 1 and will incur a \$25 reinstatement fee in addition to the dues owed.
