<b>Membership Categories</b>	
<b>Standard -</b>	Membership is in the name of the individual and the individual or their company pays the annual dues.
<b>Basic Corporate –</b>	Membership is in the name of the company and the company representative can change without penalty or without an additional application fee. Annual dues require a premium for this privilege.
<b>Multiple Corporate –</b>	Discounts are available for multiple members from the same company. The membership is in the name of the individual but the company is paying for it.
<b>Spouse –</b>	A spouse of an existing member receives a discount in both the annual dues and the application fee.
<b>Young Professional –</b>	Individuals, under the age of 35, as of October 1st of the current year, receive a discount in both the annual dues and the application fee
