Coach Bill Conley

Vice President, MAX Sports Center

During his 17 years as an assistant football coach for the Ohio State Buckeyes, Bill Conley coached tight ends, linebackers, defensive ends and special teams for head coaches Earle Bruce, John Cooper and JimTressel. All-American and/or eventual NFL players he coached include Cris Carter, Thomas "Pepper" Johnson, Chris Spielman, Mike Vrabel, Andy Groom, B.J. Sander, Ben Hartsock, Darnell Sanders and Mike Nugent. Conley coached teams that included the 2002 national champions and others, earning berths in numerous bowl games, including the Rose, Fiesta, Outback, Sugar, Citrus, Holiday, Hall of Fame and Cotton Bowls. As the Buckeyes' recruiting coordinator in 1991 and 1992, and then from 1994 to 2004, Conley distinguished himself and gained national acclaim. Recognized by ESPN as the No. 1



college football recruiter in the country, Conley consistently brought high-impact or "franchise" players to Ohio State. A few of those players were Eddie George, Orlando Pace, Terry Glenn, Greg Bellisari, Andy Katzenmoyer, Chris Gamble, Nate Salley and Mike Nugent.

Conley is a graduate of The Ohio State University, where he was a member of three Big Ten championship teams, including the 1968 national championship team, under legendary head coach Woody Hayes. Conley earned a bachelor's degree in education from Ohio State, and a master's degree in administration from Wright State University. In the spring of 2004, Conley retired from Ohio State and was named vice president at MAX Sports Center, a sports medicine and athletic performance institute in Columbus, Ohio. Today, he works to improve the skills of the nation's top athletes, while keeping his ears to the ground for coaches looking for that next "franchise player." Along with being one of the nation's top motivational speakers, Conley is also a radio sports analyst for 610 WTVN in Columbus, Ohio.

Kiwanis International Elects Officers for 2008-2009



Kiwanis International members from around the world elected new officers to lead the service organization during their 93rd annual convention, June 26-28, in Orlando, Fla. Elected were Don Canaday, of Fishers, Ind., as international president; Paul Palazzolo, of Springfield, Ill., as president-elect; and Sylvester Neal, of Auburn, Wash., as vice president. More than 5,500 international Kiwanis club delegates and guests attended the meeting. Our Club was represented by President Sam Vogel, President-Elect Scott Lindsey, and Past President and Past District Governor Ted Coons. Kiwanis International gives more than six million hours and more than \$100 million each year to help change the world "one child and one community at a time."

"We are filled with gratitude and humility at your allowing us to take the reins of this great organization," said President-Designate Don. "We are excited and prepared to hit the ground running for another year of Kiwanis service and growth - in the tradition cultivated and nurtured by our predecessors - the past presidents and leaders of Kiwanis International."



Don Canaday is charter president of the Kiwanis Club of Meridian Hills, Ind., near the Kiwanis International headquarters in Indianapolis, IN. He has been a member of three other Kiwanis clubs with a total of 38 years of membership. He served on Kiwanis International's board as a trustee, as vice president and president-elect in 2007-2008. He is a retired Army officer, serving 21 years in the Army and four years with the Indiana Guard and Reserve, retiring with a rank of brigadier general, and a retired business executive.

Palazzolo, past distinguished president of the Kiwanis Club of Springfield-Downtown, Ill., served as governor of the Illinois-Eastern Iowa District in 1994-95, as district

Secretary, district treasurer and as president of the district foundation board. He served as chair or member of 10 international committees before his election to the Kiwanis International board. He holds a degree in finance from the University of Illinois and is auditor of Sangamon County, Ill. He is also a licensed real estate broker.



Sylvester Neal has belonged to the Kiwanis Club of the Valley, Auburn, since 2003. He is a former member of the Kiwanis clubs of Anchorage and Fairbanks, Alaska, and was Kiwanian of the Year four times. He served as governor of the Pacific Northwest District in 2002-03. Neal is a retired Alaska state fire marshal and an ordained deacon in his church.

Jim Jennings, of Green Valley, Ariz., and Ed Hutchinson, of Cape May, N.J.

Amendment 6 - Improve efficiency during elections for international offices - Action: Approved

Amendment 7 - International president as chairman of the board - Action: Withdrawn

Amendment 8 - District representation on the Kiwanis International board - Action: Rejected

Amendment 9 - Regarding the use of the Kiwanis mark - Action: Rejected

Resolution 1 - Celebrating and fostering diversity - Action: Approved, amended to "Celebrating Inclusiveness"

Resolution 2 - Honoring Walter Sellers, past international president, upon his recent passing - Action: Approved


Dispatch Article Mentions Kiwanis

Retired Dispatch Columnist Mike Hardin wrote an article this past Sunday about the Tom Fennessey book bag project which we support. A partial excerpt follows:

"Each child will be able to select one complete outfit of clothes with underwear and socks and a new book bag crammed full of school supplies," she said. The book bag and school supplies are provided through the Tom Fennessy Back-to-School Project, which distributed 6,419 backpacks and sets of school supplies last year to urban and rural children in need in five central Ohio counties. The program, christened for the late Dispatch columnist Tom Fennessy, was launched a decade ago. Fennessy, whose work enjoyed a devoted readership, often was a champion of the underdog. He died of cancer in 1982. "This is about giving people a hand up until they can get on their feet. The children get new pencils, paper, crayons and a new bag to carry it all in. It makes them feel a little more equal."

Volunteers of America has donated 3,300 backpacks to help get this summer's campaign started. To help fill those packs, McGraw-Hill Cos. has pledged \$1,000, as has the **Kiwanis Club of Columbus**. The Worthington Hills PTA donated \$467. Through coaxing, cajoling and careful shopping, the Fennessy project is able to provide a complete set of supplies and a high-quality backpack for less than \$10 per student.
